





Revenue growth rates by sector




### EBITDA growth rates by sector






### Flatbed spot rates<sup>(1)</sup>




Dry van spot rates<sup>(1)</sup>




### Cass freight shipments index<sup>(2)(3)</sup>







## Ocean shipping rates and large U.S. port volume trends






